Goal: Whenever you do a task that could have exposed you to blood and/or body fluids, non-intact skin, and mucous membranes, you perform hand hygiene.

 Remember that after any of these activities, gloves must be removed and hand hygiene performed prior to moving to the next activity

Why is this moment so important? Helps protect residents, staff and visitors from harmful microorganisms. Helps to prevent environmental contamination with harmful microorganisms
